New contract in Asia

DRONE VOLT, a French aeronautics manufacturer specializing in professional civilian drones, has announced the signing of a contract with the Thailand Pollution Control Department through its AERIALTRONICS subsidiary, which it acquired and turned around in less than one year.

Pollution has become a serious problem in Thailand due to its negative effects on public health, company productivity and the tourism sector, which represents close to 20% of GDP in Thailand.

The Pollution Control Department has chosen the ALTURA ZENITH equipped with its PENSAR camera driven by artificial intelligence in combination with the RAE Systems chemical sensor from the US giant HONEYWELL. This innovative technological combination constitutes a major advantage in helping Thailand improve its measurements and analyses of air quality. This combination could additionally serve as a starting point for the addition of intelligent solutions to be deployed nationwide.

This contract was included in the 65 contract negotiations announced in March 2018. It notably joins the contracts with the French army, a Scandinavian army and the Dutch army announced over recent weeks.

Olivier Gualdoni, chairman / CEO of DRONE VOLT, indicated that *“this contract is highly symbolic in two regards. First, it enables DRONE VOLT group to obtain certification with a new government agency that could proceed with a large-scale deployment of this solution over the near future. Second, it demonstrates DRONE VOLT’s ability to integrate new teams and the complementary nature of the solutions that it offers its clients.”*
