DRONE VOLT, a manufacturer of professional civilian drones and expert in embedded solutions, has successfully completed an impressive cable-laying mission with its HERCULES 20, facilitating the future installation of a cable car in the middle of a city in Madagascar.

In just one day, four flights were made to pull 1,100 meters of cable through the heart of Tananarive city, with the iconic HERCULES 20 equipped with its DROPPER release system and parachutes to ensure complete safety.

With meticulous planning and state-of-the-art technical expertise, our experts are well-positioned to obtain the necessary permits.

The success of this strategic operation, which lasted seven days, demonstrates the DRONE VOLT team's efficiency and expertise in executing large-scale projects, even in complex urban environments, such as replacing helicopter drops.

This phase, which precedes unrolling the final cable, marks a significant step forward in the project to connect two system stations.

The renewal of such an operation in the coming weeks confirms DRONE VOLT's ability to address previously unexplored challenges with innovative and reliable solutions.

"We are very pleased that this challenging mission in Tananarive was a success," said Marc Courcelle, CEO of DRONE VOLT. "It's a testament to our ability to meet the most complex technical challenges while maintaining the highest safety and regulatory compliance standards."

Since the beginning of the year, interest in our large UAV, the HERCULES 20, has been strong across all our business activities, with 10 spray versions delivered and invoiced, an increase of 50%, and a firm order for three more HERCULES 20s.
